Med henvisning til Toldkodeksens (952/2013) artikel 18, stk. 1 giver jeg hermed ovenfor nævnte speditør fuldmagt til at udføre de i henhold til lovgivningen påkrævede toldopgaver ved henholdsvis import og eksport af gods til og fra EU. Speditøren udfører opgaverne i undertegnedes navn og på undertegnedes vegne (direkte repræsentation). Fuldmagten omfatter udfærdigelse af tolldokumenter så som eksempelvis, men ikke begrænset til, A.TR. Certifikater, EUR1 Certifikater og T2L Certifikater samt ethvert andet dokument.

Uden at dette ændrer på min ret til efterfølgende og selvstændigt at rette krav mod speditøren for toldrelaterede krav opstået som følge af speditørens uagtsomhed, er jeg forpligtet til at holde speditøren skadesløs for ethvert krav toldmyndighederne måtte rette mod speditøren i anledning af de under fuldmagten udførte opgaver.

With reference to the UCC Regulation (952/2013) article 18, section 1, I hereby appoint the above named freight forwarder to effect customs clearance services required by law regarding import or export of goods to or from the EU. The freight forwarder will conduct the services in the name of and on behalf of the undersigned (direct representation). This power of attorney concerns completion of customs documents such as, but not limited to, A.TR. Certificates, EUR1 Certificates and T2L Certificates as well as any other document.

Notwithstanding my right to subsequent and individual pursuit of a claim against the freight forwarder for customs related claims due to the freight forwarder's negligence, I am obliged to keep the freight forwarder harmless of any claim the customs authorities may pursue against the freight forwarder as a consequence of any performance subject to this power of attorney.

Member of the Danish Freight Forwarders Association and the Nordic Association of Freight Forwarders. All services rendered are subject to the General Conditions of the Nordic Association of Freight Forwarders (NSAB 2015). As contracting party cf. § 3 B the conditions limit the freight forwarder's liability for loss of, deterioration of, or damage to goods to SDR 8.33 per kilo and for delay to the amount of the freight, and for all other loss to SDR 100,000 in respect of each assignment (§ 21). As intermediary cf. § 3 C the freight forwarder's liability is limited to SDR 50,000 in respect of each assignment and totally in the event of any one occurrence to SDR 500,000 (§ 24). For storage, the total liability is limited to SDR 500,000 for damage occurring in the same occasion (§ 25). Special attention is directed to the network clause (§ 2); claims against the freight forwarder are statute-barred after one year (§ 28); and the lien on goods (§ 14) applies to both current and previous claims.
